THIS GRANT IS FUNDING THE INTRA-ARTERIAL ADMINISTRATION OF CHEMOTHERAPY FOR TRANSITIONAL CELL CARCINOMA (TCC) WHICH IS THE MOST COMMON TUMOR OF THE CANINE URINARY TRACT. WE ARE HOPING TO ACHIEVE (1) LOWER SYSTEMIC TOXICITIES, (2) HIGHER LOCAL TUMOR CHEMOTHERAPY DOSES AND THEREFORE IMPROVED REMISSION RATES, AND (3) ULTIMATELY THE ABILITY TO ADMINISTER HIGHER DOSES OF CHEMOTHERAPY THAN PREVIOUSLY TOLERATED BECAUSE OF THE REDUCED SYSTEMIC EXPOSURES.
